RATIONALIZING THE AMOUNT OF ENTRANCE FEE AND RATES OF COTTAGES, ROOM RENTALS, TREE HOUSES, AND FACILITIES AND AMENITIES AT CALAWAGAN MOUNTAIN RIVER RESORT.

BE IT ORDAINED, by the Sangguniang Bayan of Paluan, Province of Occidental Mindoro, in session duly assembled that:

SECTION I. SHORT TITLE - This Ordinance shall be known as the **“Calawagan Fees 2024”**.

SECTION II. RATES AND FEES. - That following are the new rates of entrance fee, cottages rental, tree houses rental, room rental, hotel rental, amenities and facilities in Calawagan River Resort:

SECTION III. PROHIBITED ACTS AT CALAWAGAN RIVER RESORT - That all people who are inside the vicinity of Calawagan River Resort shall follow what is stated in Republic Act 8550. Moreover, the following acts are strictly prohibited inside the vicinity of the Calawagan River Resort:

1. Drinking and eating are prohibited beside and within the pool and the river area.
2. Littering in the jurisdiction of the Calawagan River Resort.
3. Vandalism inside the premises of Calawagan River Resort.
4. Destruction of anything owned by Calawagan River Resort.
5. Setting up of "tungko" and cooking using firewood or charcoal in open areas particularly beside the river. (cooking can be done in designated cooking areas)

SECTION IV. PENAL PROVISION. - Violation of any of the provisions of this ordinance not herein otherwise covered by a specific penalty shall be punished by a fine of (Php 2,500.00).

SECTION V. SEPARABILITY CLAUSE. - If for any reason , any part of this ordinance shall be declared to be unconstitutional or invalid, other parts of provisions hereof which are not affected thereby continue to be force and effect.

SECTION VI. REPEALING CLAUSE. - All orders, rules and regulations, ordinances or part thereof, inconsistent herewith are hereby repealed or modified accordingly.

SECTION VII. EFFECTIVITY- This ordinance shall take effect immediately upon approval and compliance of the provisions of the existing laws on posting and publications.

Section II. That the following acts are strictly prohibited inside the vicinity of the Calawagan River Resort:

6. Drinking and eating are prohibited beside and within the pool and the river area.
7. Littering in the jurisdiction of the Calawagan River Resort.
8. Vandalism inside the premises of Calawagan River Resort.
9. Destruction of anything owned by Calawagan River Resort.

Section III. That all people who are inside the vicinity of Calawagan River Resort shall follow what is stated in Republic Act 8550.

Section IV. PENAL PROVISION- Violation of any of the provisions of this ordinance not herein otherwise covered by a specific penalty shall be punished by a fine of not less than One Thousand Pesos (Php 1,000.00) but not more than Two Thousand Five Hundred Pesos (Php 2,500.00) or imprisonment at the discretion of the court.

Section V. SEPARABILITY CLAUSE- If for any reason , any part of this ordinance shall be declared to be unconstitutional or invalid, other parts of provisions hereof which are not affected thereby continue to be force and effect.

Section VI. REPEALING CLAUSE- All orders, rules and regulations, ordinances or part thereof, inconsistent herewith are hereby repealed or modified accordingly.

Section VII. EFFECTIVITY- This ordinance shall take effect immediately upon approval and compliance of the provisions of the existing laws on posting and publications.
