AUTHORIZING THE HONORABLE MUNICIPAL MAYOR, MICHAEL O. DIAZ TO PURCHASE VEHICLE FOR THE USE OF MUNICIPAL VICE MAYOR.

WHEREAS, the Municipal Mayor needs the authority of the Sangguniang Bayan to purchase the motor vehicle to be utilized by the Local Government Unit of Paluan;

WHEREAS, there is a need to purchase the vehicle to support the operation and services rendered by the Office of the Sangguniang Bayan headed by the Municipal Vice Mayor;

NOW THEREFORE, be it ordained by the Sangguniang Bayan in session assembled:

Section 1. TITLE. – This Ordinance shall be called “Ordinance Authorizing the Honorable Municipal Mayor, Michael O. Diaz to Purchase Vehicle for the Use of the Sangguniang Bayan Office headed by Municipal Vice Mayor”.

Section 2. APPROPRIATION. – The appropriation for the purchase of vehicle was hereby approved and authorized:

**One (1) Unit Pick-up
For the use of the Sangguniang Bayan Office
3000 cc / Diesel Fed
4-Cylinder In-Line, 16 Valve Double Overhead Camshaft**

Section 3. AUTHORITY. – The Municipal Mayor is hereby authorized to sign all documents necessary to effectuate the said purchase of vehicle.

Section 4. COMPLIANCE – Compliance to all auditing rules, regulations and circulars issued by the COA and the Department of Finance shall be strictly complied with by the Officials concerned.

Section 5. SEPARABILITY CLAUSE. – If for any reason any part of this Ordinance shall be held unconstitutional or invalid other parts thereof which are not affected thereby shall continue to be in full force and effect.

Section 6. EFFECTIVITY. – This ordinance shall take effect immediately.
