Municipal Ordinance No. 2024- 10

Series of 2024

AN ORDINANCE GRANTING FRANCHISE TO MR. MARIO J. RAMOS TO OPERATE AND MAINTAIN A COCKPIT ARENA IN THE MUNICIPALITY OF PALUAN, OCCIDENTAL MINDORO.

BE IT ENACTED by the Sangguniang Bayan of Paluan, Occidental Mindoro in session assembled, that:

WHEREAS, the Sangguniang Bayan as a legislative body, by express provision of law is empowered and authorized to license and grant franchise for the establishment, operation and maintenance of cockpits, regulate cockfighting activities and breeding of cockfighting cocks within its territorial jurisdiction, providing that existing rights should not be prejudiced;

WHEREAS, Mr. Mario J. Ramos in his individual capacity has filed his application to be granted a franchise to operate a cockpit arena in view of the expiration of the franchise granted to the MjR Tikian Cockpit Arena;

WHEREAS, upon consideration of the guidelines in the grant of franchise to operate cockpit as provided for and prescribed under existing laws appears that Mr. Mario J. Ramos, a Filipino citizen and resident Paluan, Occidental Mindoro had substantially complied said requirements;

NOW, THEREFORE, BE IT ORDAINED THAT:

SECTION 1. NATURE, SCOPE AND GRANT OF FRANCHISE. – Subject to the provisions of applicable laws, rules, and regulations a franchise to operate and maintain a cockpit within the municipality of Paluan, Occidental Mindoro is hereby granted to Mr. Mario J. Ramos, a Filipino citizen and resident of Paluan Occidental Mindoro (herein referred to as the grantee). As such, he is authorized to establish and operate one (1) cockpit arena specifically located at Sitio Tikian, Barangay IX- Tubili, Paluan, Occidental Mindoro;

SECTION 2. DECLARATION OF FRANCHISE. – Unless sooner revoked or cancelled, this franchise shall be valid for a period of FIVE (5) years on August 19, 2024 up to August 18, 2029 with the option on the part of the Grantee to renew the same for a similar period and subject to the approval of the Sangguniang Bayan;

SECTION 3. AUTHORITY OF THE OFFICE OF THE MAYOR- The Grantee shall apply and secure the required business permit to operate from the Office of the Mayor and the latter shall have the authority to require compliance of all existing laws, ordinances, rules and regulations similarly imposed to all business establishments, and impose conditions thereto as are expressly or impliedly necessary for the protection of the welfare and safety of all persons going or transacting in said cockpit;

SECTION 4. PROHIBITION ON SALE, LEASE, USUFRUCT AND TRANSFER OF FRANCHISE

– This Franchise is non-transferable in character. As such, the Grantee shall not sell, assign, lease, grant the usufruct of, or transfer this franchise including any rights and privileges acquired thereunder, to any person, natural or juridical, firm other entities, nor merge with any corporation or individual without the prior notice and approval of the Sangguniang Bayan;

SECTION 5. MANDATORY PAYMENT OF TAXES AND FEES PROVISION.

– The Grantee shall be liable to pay all taxes and other fees prescribed by the Revised Revenue Code of the Municipality of Paluan, Occidental Mindoro to the office of the Municipal Treasurer. Said assessments shall be without prejudice to the subsequent impositions as may be adopted or hereafter may be required by law or ordinance. Failure on the part of the grantee to promptly and regularly comply with said tax obligations shall be a ground for the revocation or cancellation of this franchise;

SECTION 6. REVOCATORY CLAUSE.

– This franchise including the complementing business permit to operate shall be automatically revoked or cancelled upon showing of any noncompliance of the conditions set forth therein, and for any of the provisions of P.D. 449 and other pertinent ordinances, rules, and regulations;

SECTION 7. EFFECTIVITY

- The ordinance shall take effect immediately upon its approval.
