**ORDINANCE ESTABLISHING THE RICE MILLING FEE IN THE
MUNICIPALITY OF PALUAN, OCCIDENTAL MINDORO.**

Sponsored by: Honorable Marrian M. Ibañez

WHEREAS, the current rice milling fee in the municipality is Two Pesos per Kilo (Php 2.00/Kilo) or one “salop” per Fifty Kilos of palay. The Rice Miller Association in the Municipality of Paluan requested this August Body for a reasonable increase of rice milling fee due to the continuous price increase of fuel, parts and maintenance of rice milling machines;

WHEREAS, products, services (particularly on energy and transportation) and basic commodities that rely heavily on oil have already increase as most of these products are transported by gas-powered vehicles from faraway farms to the markets.

WHEREAS, The Department of Energy (DOE) says the surge in global oil prices was triggered by Ukraine war. In the Philippines' first double-digit increase in the cost of gasoline was noted last March 15. The price of diesel rose 13.15 pesos per liter and gasoline 7.10 pesos. The cost of the two fuels has risen by 30.65 pesos and 20.35 pesos, respectively.

BE IT ORDAINED, by the Sangguniang Bayan of Paluan, Occidental Mindoro in session duly assembled that;

SECTION I. The price of the rice milling fee in the Municipality of Paluan shall be determined according on the fuel price schedule below. The payment shall be as follows:

Fuel Price (Php)	Rice Milling Fee per Kilo of Palay
50.00 to 70.00	Php. 3.00
71.00 to 90.00	Php. 3.50
91.00 to 110.00	Php 4.00

In such case that the customer wants to pay the rice miller in form of rice, the payment shall be as follows:

For every 10 Kilos of Palay the payment shall be 1 Kilo of Rice.

SECTION II. Penalties. The rice miller who violate or increase the price of the milling fee stated in Section I shall be punished through the imposition of the following penalties:

First offense : Php 1,000.00 fine
Second Offense : Php 2,000.00 fine

Third offense : Php 2,500.00 fine and/or imprisonment of more than 6 months upon the discretion of the court and cancellation of their license to operate for a period of one (1) year.

SECTION III. Separability Clause. If any part of this ordinance is declared as unconstitutional or unlawful, such declaration shall not affect the other parts or sections hereof that are not declared unlawful or unconstitutional.

SECTION IV. Effectivity. Effectivity necessary for the good of public service and immediate response to the timely need, this Ordinance shall take effect **immediately** until Sangguniang Bayan lifts or recommended by the Sangguniang Panlalawigan.

Enacted this 1st day of August 2022, at the Sangguniang Bayan Session Hall, on motion of the Chairman of the Committee on Tourism, Trade and Industry, Honorable **Marrrian M. Ibañez** and duly seconded by the August body.
